Item A. Reviewing Interested Candidates for Vacant Commissioner Position

Mayor Cox made a motion to appoint Jimmy Jack as the new commissioner. Commissioner Hackler seconded. Alison Bull gave roll call with Commissioners Martin and Hitt voting in opposition and Commissioner Hackler and Mayor Cox voting in favor of Jimmy Jack. Motion failed.

Commissioner Martin made a motion to appoint Dwayne Arrowood for Commissioner. Commissioner Hitt seconded. Bull gave roll call with Commissioners Martin and Hitt voting in favor of Arrowood and Commissioner Hackler and Mayor Cox voting in opposition. Motion failed.

Commissioner Martin made a motion to appoint Randy Reddish as Commissioner. Commissioner Hitt seconded. Bull gave roll call with Commissioners Martin and Hitt voting in favor of Reddish and Commissioner Hackler and Mayor Cox voting in opposition to him. Motion failed.

Commissioner Martin made a motion to appoint Belinda Holt for commissioner. Motion failed for a lack of a second.

Commissioner Hitt made a motion to appoint Jimmy Jack for commissioner. Commissioner Hackler seconded. Bull gave roll call. Commissioner Martin voted in opposition, Commissioners Hitt and Hackler voted in favor, along with Mayor Cox. Motion passed with Jimmy Jack being appointed Commissioner.

Item B. Hiring a Town Manager

Commissioner Hitt nominated Miles Wolf to become Town Manager. Commissioner Martin Seconded. Bull did roll call with Commissioners Martin and Hitt voting in favor of Mr. Wolf and Commissioner Hackler and Mayor Cox voting in opposition. Motion failed.

Mayor Cox made a motion to appoint Brittany Freeman as Town Manager. Commissioner Hackler seconded. Bull did roll call with Commissioners Martin and Hitt voting in opposition and Commissioner Hackler and Mayor Cox voting in favor of Ms. Freeman. Motion failed.




A decision was made to move the appointing of Town Manager to the regular scheduled meeting on Monday, September 11, 2017 once the new commissioner is sworn in.
