## Minutes from the Commission Meeting held on

## **December 1, 1987**

The Mayor and Board of Commissioners of the Town of Englewood met in regular session Tuesday, December 1, 1987, at 7:30 p.m. at Englewood City Hall.

Mayor Middleton called the meeting to order with Commissioners Conner, Armstrong, and Nichols present. Also present was Eva Moses, Recorder C.A. Goodin, Chief Hershell Jack, and citizen Carrine McConkey.

Eva Moses was then sworn in as commissioner by Mayor Bob Middleton to fill the vacancy left by deceased Commissioner Willard Reid.

After reviewing the minutes of the previous meeting, motion was made by Armstrong and seconded by Conner to accept the minutes. All ayes.

Commissioner Armstrong then informed the Board that two auto accidents had occurred in the last few weeks at the intersection of College Street and Tellico Street (Hwy 39). Recorder Goodin had notified the state of this problem and was informed that the town should handle it. The Board decided that a letter should be sent to property owner Eddie Webb to move any obstruction blocking the intersection in order to prevent further accidents.

Commissioner Nichols then asked Chief Jack about a form being signed by patrolmen asking that they discuss any problems with him before taking it before a Board member. Chief Jack stated that the form was presented to patrolmen to insure that they go through channels with any problems they might have. Commissioner Armstrong commented that employees should go to their supervisors with any problems, as that was one of the reasons for having supervisors.

The Board then discussed a rumor that Glenn Cooley would be resigning as patrolman. The Mayor stated that he and Chief Jack met with Cooley to iron out any problems if any pertaining to this subject.

Mayor Middleton stated that new patrolman Queen and Gates were doing a good job as patrolman for the city.

Commissioner Nichols made a motion that any problems occurring in the Police Department that were urgent should be brought to the Mayor as there was currently no Police Commissioner due to the death of Willard Reid. Motion was seconded by Conner. All ayes.

Motion was then made by Conner, seconded by Middleton to give employees a Christmas bonus of 1 percent. All ayes.

Recorder Goodin informed the Board that they needed to look into paving that would need to be done in the Spring. Commissioner Armstrong recommended that letters be sent to residents where paving was to be done informing them that any gas taps that were needed in that area would have to be done before the paving begun.

The Board then discussed the sewer infiltration problem occurring at the Post Office area. It was recommended that the Engineers check into this and recommend a solution.

Mayor Middleton stated that Therman McConkey would like to have gas put in at his residence but that permission would have to be obtained from the state before this could be followed up.

Middleton also informed the Board that the McBrayer property would need to be surveyed before Spring.

Commissioner Conner asked Recorder Goodin if the M&M and Allied garbage was still being weighed. Goodin stated that the larger loads were being weighed.

motion was made to adjourn by Conner, seconded by Nichols. All ayes.
