## Minutes from the Commission Meeting held on

May 3, 1988

The Mayor and Board of Commissioners of the Town of Englewood met in regular session, Tuesday, May 3, 1988, at 7:30 p.m. in the Englewood Library.

The meeting was called to order by Mayor Robert Middleton with Commissioners Nichols, Moses, and Conner present. Commissioner Lendell Armstrong was not present.

After reviewing that minutes of the previous meeting, motion was made by Moses, seconded by Conner that they will be accepted. All ayes.

Motion was made by Conner, seconded by Nichols to approve paving on following streets: Locust, Ferguson, Cagle, Glendale, Melrose, Tellico Pike, and from Main Street to Hwy 411 in the amount of \$29,911.00. All ayes.

After discussion concerning over \$50,000.00 in excess funds from the recent Sewer Treatment Plant project, motion was made by Nichols, seconded by Conner to proceed with having engineers prepare a plan to add about eleven houses to sewer on Hwy 39. All ayes.

The Board then discussed repairing the air conditioning system at City Hall. Two bids had been submitted by Cross and Son for \$5886.00 and All Seasons for \$6250.00. The Board decided t wait until a bid was received from Hampton Heating and Air before making a final decision.

Motion was then made by Conner and seconded by Moses to donate \$800.00 to the McMinn Adult Activities Center in Athens. All ayes.

Motion was made by Conner and seconded by Middleton to adopt the following resolution. Conner aye, Middleton aye, Nichols abstained, Moses abstained.

After discussion of Police Department, motion was made by Conner, seconded by Nichols to hire David Pruitt as part-time police officer. All ayes.

The Mayor then discussed with he Board the possibility of blocking off Athens Pike.

Chief Jack informed the Board that the radar mounted in the patrol car was getting old. After discussing leasing a radar gun, the Board decided to hold further discussion of this during the Budget hearings.

The Board then reviewed applications for pool manager and lifeguards. Motion was made by Conner seconded by Nichols to hire Keith Moses as Pool Manager with Jill Pickens as lifeguard, Kimberly Hamilton as lifeguard, and Shannon Cooley as substitute

lifeguard. The Board voted as follows: Middleton aye, Conner aye, Nichols aye, Moses abstained.

The Board then discussed a complaint from Mrs. Frank Patterson that four feet of her property had been taken when the road in front of her residence was paved to the Cherokee Hill Apartments.

The Board then discussed forming a county wide dog pound due to increasing dog problems in the City.

Motion was then made by Nichols, seconded by Conner to adjourn the meeting. All ayes.
