Minutes from the Commission Meeting held on

February 5, 1990

The Mayor and Board of Commissioners of the Town of Englewood met in regular session, Tuesday, February 5, 1990 at 7:30 p.m. in the Assembly Room at City Hall.

Mayor Conner called the meeting to order with Commissioners: Brown, Long, Armstrong, and Cass present. Recorder C.A. Goodin was also present.

A moment of silence was observed before reviewing the previous minutes of the regular and called meetings. Motion was then made by Armstrong, seconded by Long to accept the minutes of the regular meeting held in January and the called meeting held in January. All ayes.

Jane Flowers and Patsy Decker were present informing the Board that they had attended a meeting on Downtown Revitalization in Etowah. The object of the meeting was to look into ways of improving downtown areas of cities.

They Mayor then asked Flowers and Decker if they would attend a seminar sponsored by the Knox Area section of the Tennessee Chapter, America Planning Association to be held in Pigeon Forge on February 23. Flowers and Decker agreed to attend.

Utility Service representative Frank Bourne was present asking that the Board give consideration to the proposal that had been presented in reference to upkeep of water tanks.

Lee Robinson was present asking the Board to consider the installation of a waterline on Hwy 39 near the Packing House. The Board stated that a six inch line would be required and that a plan would have to be sent to the State and approved before any further consideration could be made.

The Board then discussed the request for gas installation on the James Burnette property. Mr. Goodin stated that the cost would be in the area of \$1000.00. A motion was made by Cass, seconded by Armstrong to install gas at the Burnette residence. All ayes. The Board then informed me. Burnette that they could not give him a definite time that the installation would be done.

Scout leaders Bill and Diane Constance were present to discuss conflict between Senior Citizens and Scouts concerning both parties use of the Community Center. The Board informed the Constance's that Police Chief Hershell Jack would check into the matter and inform the Board of what the problem was.

Police Chief Hershell Jack requested that the Board continue to pay the Drug Task Force Officer's salary for another six months. Jim Hitson, acting director of the Drug Task Force was present in support of Chief Jack. MR. Hitson explained to the Board that the Drug Task Force was hoping to become self-supporting in the near future. Motion was

made by Cass, seconded by Armstrong to support the Drug Task Force officer for three months with the stipulation that any funds recovered by the Drug Task Force would be paid to the General Funs to cover this salary. All ayes.

Mr. Goodin informed the Board that the owner of Newman Trailer Park had requested permission to place water meters at each trailer at the owner's expense. The Board agreed that there would be no problem with this.

The Board instructed Mr. Goodin to purchase a gear box for the Sewer Plant that was in need of repair.

The Board stated that all the part-time police officers be paid \$4.75 per hour. The Board also stated that Reserve Officers be used on weekends instead of part -time officers.

Commissioner Long stated that all employees must use purchase orders when purchasing any items costing over \$50.00

Motion was made by Brown, seconded by Armstrong that regular Dispatchers be paid for time worked if called in to relieve another dispatcher in an emergency situation. All Ayes.

Motion was made by Armstrong, seconded by Brown that the meeting be adjourned. All Ayes.
