

Minutes from the Commission Meeting held on

May 8, 1990

The regular session of the Englewood Board of Commissioners convened on May 08, 1990 at 7:30 p.m. with a call to order by Mayor Wanda Conner. Commissioners present were Conner, Armstrong, Cass, and Long.

The meeting was opened with a word of prayer by Steve Lee.

Paula Fletcher of the AYSO Soccer League was present informing the Board that the League was expanding and they needed more fields. She stated that Cullen Smith had agreed to donate land adjacent to the city park if a lease could be worked out. A motion was then made by Cass and seconded by Armstrong to approve this agreement for city attorney Jeff Cunningham to work with Cullen Smith on a lease. All vote aye. Armstrong then made a motion to donate \$250 to the league to sow grass on the new field. The motion was seconded by Cass. All ayes.

Resident Wanda Lewis was recognized next and requested that the city develop a policy to average the last three months water and sewer bills if an unfortunate circumstance happens such as a bad leak. After lengthy discussion Commissioner Cass stated that this would be looked into.

W.C. Thomas then asked concerning the status of the gas service request that had been made for Old Englewood Road. Commissioner Long then made a motion to install both loops of gas based on a proposal by Jess Guinn which included \$11,400.00 for one loop and \$6953.00 for the second. The motion was seconded by Armstrong. Upon roll call vote, the following stated: Long-aye, Conner-aye, Armstrong-aye, Cass-aye.

Dianne Constant representing the Boy Scouts, was present to request service projects for the Boy Scouts. It was agreed that paint and brushes be bought so the Boy Scouts could paint fire hydrants.

Rick Peeler, representing 13-14 year old Dizzy Dean Baseball, then requested a donation from the Commission to help the Englewood team. A motion was made by Armstrong and seconded by Cass to donate \$250 to the Englewood Dizzy Dean Baseball team. All ayes.

Pat Decker of the Englewood Municipal Planning Commission then informed the Board that the State Planning Commission had finished the water, gas, and sewer maps for the Town and would like the Commission's approval to have them color-coded. A motion was made by Conner and seconded by Armstrong to proceed with the color-coding of the utility maps. All ayes.

Bobbie Dickson of the Englewood Community Action Group then came before the Board to inform them that the group was looking for a building for a museum. She then stated that the Mayor had suggested using the front part of city hall for the museum. On behalf

of the CAGE, Ms. Dickson asked that they be allowed to use all of the area from the front back to the collection office which would mean the taking of the Chief of Police office and the Recorder's office. They also asked for a 20 year lease. A motion was made by Armstrong and seconded by Long to grant the request of the CAGE for the use of city hall for a museum. All ayes.

Chief of Police Jack then proposed that the Town of Englewood become a part of the Tennessee Law Enforcement TV Network to take advantage of the 24 hour training for police officers. He stated that it was highly endorsed by the TML. The cost of receiving this program will be \$288 per month. TML will pick up the first month bill, the Drug Fund will pay for 6 months, and the City will pay for the final 5 months. A motion was then made by Long and seconded by Cass to place this in the budget. All ayes.

Cass then asked if painting the water tanks was going to be in this year's budget and the Commissioner's all agreed that it would be. He then asked what the Board wanted to do concerning the garbage rates. In regards to the garbage rates, the following motions were made: (1) Motion by Cass, seconded by Armstrong to raise businesses to the following rates:

All voted aye.

(2) Motion was then made by Long and seconded by Armstrong to raise the garbage bill for Allied Hosiery Mill to \$350.00 with the option to haul their own if they chose. This amount was based on the cost to dump their garbage, the mileage, gas, and labor. Upon a roll call vote, all commissioner's voted aye except Cass who voted no.

(3) Motion was then made by Cass and seconded by Long to raise residential garbage rates from \$4.00 to \$5.00. Upon roll call vote, the following voted: Brown-Yes, Long-Yes, Conner-No, Armstrong-No, Cass-Yes.

Commissioner Cass then asked concerning the paving of the road leading to the pool. Funds budgeted for this amount were not used this past fiscal year, and the Board agreed to carry this amount into the next fiscal year.

Commissioner Cass then inquired about the ditch on Sunset that was causing problems. Armstrong stated that this would be looked at again.

Inquiry was made into applications that had been received for certified water and sewer operators.

A motion was then made by Armstrong and seconded by Brown to retain B.J. King of Knoxville as auditor for fiscal year 1990-91. All ayes.

A motion was then made by Armstrong and seconded by Armstrong to remove the following accounts from accounts receivable as bad debts:
