Minutes from the Commission Meeting held on

March 2, 1993

The Mayor and Board of Commissioners of the Town of Englewood met in regular session on Tuesday, March 2, 1993 at 6:00 p.m. in the assembly room at City Hall.

The meeting was called to order by Mayor Bob Cass with Commissioners Long, Davis, Casteel, and Peeler present. The invocation was given by Commissioner Davis.

Motion was made by Long and seconded by Peeler to accept the February 1993 Board meeting minutes. All ayes.

Commissioner Davis reminded the Board that the issue of the Mamie Conner property near the lift station needed to be looked into because Ms. Conner would like to go ahead and make a deed concerning her property.

Motion was made by Peeler, seconded by Davis to place a demand charge of \$3.00 on all inactive gas meters located on customer's property. All ayes.

Motion was made by Casteel, seconded by Peeler that the Town purchase two pagers to be used by the Maintenance and Water Departments. All ayes.

Motion was made by Casteel, seconded by Peeler that two Cerebral Palsy Fund Raisers could be held in Englewood each year. All ayes.

Concerning water cut off rates, motion was made by Peeler, seconded by Casteel that:

- * cut-off fees be raised from \$10 to \$20, Monday-Friday, 8:00 a.m. to 5:00 p.m.
- * after hour cut-off fees be set at \$30, Monday-Friday, 5:00 p.m. to 8:00 p.m.
- * a fee of \$40 be charged for reconnection of services on Saturdays, Sundays, and Holidays, 8:00 a.m. to 5:00 p.m. only.

All ayes.

Mayor Cass then stated that customers would not be allowed to reconnect their own services, that only utility personnel would be allowed to do so. Violation of this Ordinance #13-123, will result in the violator being cited into city court and subject to fines up to \$50.00.

Motion was made by Peeler, seconded by Long to make Stacy Casteel Fire Chief for the city's fire department. Davis-Aye, Long-Aye, Peeler-Aye, Casteel-Pass.

Motion was made by Peeler, seconded by Davis to make Wayne Williams Life Time Honorary Fire Chief. All ayes.

Concerning the Hepatitis B vaccinations, the Board was in agreement that employees should be given the opportunity to receive the shots on a voluntary basis. The city

would not be responsible for anyone who ref used. The Mayor stated that the Personnel Policy should be amended in regard to this issue.

Motion was made by Long, seconded by Peeler, to initiate procedures on lead/copper testing. All ayes.

Motion was made by Peeler, seconded by Long, to reopen the bids on the firetruck, without minimum, with the city retaining the right to refuse any and all bids. Davis-Aye, Long-Aye, Peeler-Aye, Casteel-Aye, Cass-Opposed.

Motion was made by Peeler, seconded by Long to adjourn. All ayes.
