

**Minutes from the Commission Meeting held on
September 6, 1994**

The Mayor and Board of Commissioners of the Town of Englewood met in regular session, Tuesday, September 6, 1994 at 6:00 p.m. in the Assembly Room at City Hall.

The meeting was called to order by Mayor Cass with Commissioners Davis, Long, Peeler, and Casteel present.

Invocation was given by Commissioner Davis.

Motion was made by Casteel, seconded by Peeler to promote Assistant Chief Glenn Cooley to the position of Chief of Police. All ayes.

Motion was made by Peeler to hire Danny McDonald and Billy Farmer as full time police officers. ***Motion died from lack of a second***

Commissioner Davis then asked Chief Cooley which officers he recommended. Cooley informed the Board that he recommended Danny McDonald and Billy Farmer.

Motion was made by Long to hire Billy Bivens as police officer. ***Motion died from lack of a second***

Motion was made by Peeler, seconded by Davis to hire Danny McDonald and Billy Farmer as full-time police officers. Davis-Aye, Long-Nay, Peeler-Aye, Casteel-Aye.

Motion was made by Davis, seconded by Casteel to pay certified police officers \$7.00 per hour, non-certified police officers \$6.00 per hour, with a 25 cent raise after 90 days. All ayes.

Motion was made by Peeler, seconded by Davis to sell three bullet proof vests to Hershell Jack, Tim Smith, and Steve Frisbie for \$1.00 each. All ayes.

Mayor Cass then presented former Police Chief Hershell Jack, and former Police Officers Tim Smith and Steve Frisbie with plaques for outstanding and dedicated service. A plaque was also given to the Assistant Recorder for Carolyn Goodin, who was not present at the meeting.

Motion was made by Casteel, seconded by Long to move Terry Elliott from part-time police officer to full-time. All ayes.

Motion was made by Long, seconded by Casteel to increase J.L. Gay's pay rate to that of a non-certified officer. All ayes.

Motion was made by Casteel, seconded by Peeler to run an ad in the newspaper for the position of City Recorder. All ayes.

Motion was made by Davis, seconded by Casteel to place Deborah Morgan in the position of Assistant Recorder. All ayes.

Motion was made by Casteel, seconded by Peeler to raise Deborah Morgan's pay rate to \$8.50 per hour.

Motion was made by Casteel, seconded by Davis to hire Angela Gibson as Municipal Clerk until next Board meeting. All ayes.

Motion was made by Peeler, seconded by Casteel to pay Angela Gibson \$5.00 per hour at this time. All ayes.

Concerning Eddie Webb's sewage line, motion was made by Casteel, seconded by Davis to reimburse Mr. Webb the cost of pipe on city property. Davis-Aye, Long-Aye, Peeler-Nay, Casteel-Aye.

Motion was made by Long, seconded by Davis to hire Terry Hyde to work at the water plant. All ayes.

Motion was made by Davis, seconded by Casteel to make a \$50.00 donation to the Englewood Lion's Club. All ayes.

Motion was made by Peeler, seconded by Casteel, to pass a resolution to begin condemnation procedures on the H.F. Cochran property. All ayes.

Approve paving of streets--Tabled

Motion was made by Davis, seconded by Long to allow Charles Moses to hold a gospel singing on September 17, 1994 from 7:00 pm. until 11:00 p.m. at the Community Park. All ayes. Commissioner Davis said that he would furnish a low boy to be used as storage.

Motion was made by Peeler, seconded by Casteel, to allow the water plant operators to spend \$180.00 on a line item to eliminate chlorine problems. All ayes. The problem is located at the Greg McCamis property.

Motion was made by Davis, seconded by Peeler to abandon Kale Street and Sockhill Avenue between 3rd and 4th Streets. All ayes.

Citizens Jerry Shirk and Zella Patton were present to complain about parking problems in their neighborhood during little league football games. The Board informed them that they would meet with the league and work out the problem.

Motion was made by Casteel, seconded by Peeler to adjourn the meeting. All ayes.
