The Mayor and the Board of Commissioners met in regular session Tuesday, October 4, 1994 in the Assembly Room at City Hall.

The Mayor called the meeting to order with Commissioners Davis, Long, Peeler, and Casteel present. Invocation was given by Commissioner Davis.

Motion was made by Casteel, seconded by Davis to accept the minutes of the August and September meetings. All ayes.

Motion was made by Long, seconded by Peeler to amend the Street Paving budget from \$30,000.00 to \$42,000.00. All ayes.

Motion was made by Casteel, seconded by Peeler to pave the following streets, giving the authority to accept the lowest bid: Barnett St., Main St., Oak St., and going with priming seal on 3rd and 4th Streets and Dodson between 3rd and 4th. All ayes.

Motion was made by Peeler, seconded by Casteel approve contract between Englewood and Etowah on Utilities Grant. All ayes. \*\*\*Citizens Darrell and Carrine McConkey, and Raymond Roach were present to discuss Englewood purchasing water from Etowah.

Motion was made by Peeler, seconded by Long to approve license for Radio Channel. All ayes.

Motion was made by Peeler, seconded by Casteel to accept General Agreement and Running Bond-Department of Transportation. All ayes.

Park and Pool Repairs--tabled for work session.

Motion was made by Casteel, seconded by Davis to pass a resolution that any employee working in a position that requires them to be certified; the employee must fulfill this requirement. All ayes.

## RESOLUTION

Passed and adopted by the Mayor and Board of Commissioners of the Town of Englewood the 4th day of October, 1994.

Concerning clean up of City Rent House property, Commissioner Davis stated that he would check on estimates to have the work done. Motion was then made by Long, seconded by Davis to give Mayor Cass the authority to spend up to \$150.00 on the project.

Sale of un-need city vehicles and confiscated vehicles--tabled by motion made by Peeler, seconded by Casteel. All ayes.

Motion was made by Long and seconded by Casteel to hire Joe Cline on a part-time basis, 3 hours at the water plant (8:00 a.m.-11:00 a.m.) and 3 hours at the sewer plant (12:00 noon-3:00 p.m.). Long-Aye, Davis-Aye, Casteel-Aye, Peeler-Aye.

Motion was made by Peeler to pay Mr. Cline his original base pay of \$7.50 an hour. Motion died from lack of a second.

Motion was made by Casteel, seconded by Davis t pay Joe Cline \$10.00 per hour. Davis-Aye, Long-Aye, Casteel-Aye, Peeler-Nay.

Motion was made by Peeler, seconded by Long to accept on first reading Ordinance #100494 rezoning an area currently zoned C-2 to R-2. All ayes.

Motion was made by Casteel, seconded by Peeler to pay \$325.00 for Cathodic Protection. All ayes.

Motion was then made by Casteel, seconded by Peeler to adjourn the meeting. All ayes.
