

**Minutes from the Commission Meeting held on**

**August 6, 1996**

The Mayor and Board of Commissioners of the Town of Englewood met in regular session, Tuesday, August 6, 1996 at 6:00 p.m. in the Assembly Room at City Hall.

Mayor Cass called the meeting to order with Commissioners Long and Middleton present. Commissioners Brock and Davis were not present.

Invocation was given by Joe Cline.

Motion was made by Middleton, seconded by Long to accept the minutes from the July meeting.

Motion was made by Middleton, seconded by Long to accept on second reading the Water and Sewer Adjustment Ordinance. All ayes.

Motion was made by Middleton, seconded by Long to hire Danny Jones as Water Plant Operator. All ayes.

Motion was made by Long, seconded by Middleton to following Resolution authorizing the establishment of the Industrial Development Board of the Town of Englewood. All ayes.

The Board then decided to meet in called session, Tuesday, August 13, 1996 at 6:00 p.m. at which time Commissioners may submit names of persons qualified to be appointed to the Industrial Development Board. The Board will be appointed at the called meeting.

Motion was made by Long, seconded by Middleton to accept on first reading the Municipal Technical Advisory Service's update of the Town of Englewood Municipal Code Book. All ayes.

Motion was made by Long, seconded by Middleton to table the Hwy 39 East gas line. All ayes.

Motion was made by Long, seconded by Middleton to check into the cost of a recording system for the City Hall Assembly Room. All ayes.

Barbara Culberson was present asking for an adjustment on her water bill. She had a leak on her service line. The Board refused adjustment because adjustments are made to the sewer part of the bill for such leaks and Mrs. Culberson has no sewer at her residence.

Claudella Culberson was present asking for an adjustment due to a water leak. Motion was made by Middleton, seconded by Long to adjust the sewer on her August and September billing on a 12-month average. All ayes.

The Board was requested to place a street light at 510 Chestnut. Motion was made by Middleton, seconded by Long to have Athens Utilities Board to do a survey of the street light situation in Englewood. All ayes.

Motion was made by Middleton, seconded by Brock to accept monthly billing errors in the amount of \$2405.55. All ayes.

An estimate for repairing the utility truck was presented to the Board. Motion was made by Brock, seconded by Middleton to get two more estimates and accept the lowest of the three. All ayes.

Motion was made by Middleton, seconded by Brock to accept on first reading the Garbage Pick-up Ordinance with amendment for 35 gallon containers.

Motion to table housing for the elderly and handicapped was made by Middleton, seconded by Long. All ayes.

Motion was made by Middleton, seconded by Brock to purchase a Murray riding mower not to exceed \$1000.00 to be used at the water and sewer plants. All ayes.

Motion was made by Long, seconded by Middleton, with all ayes, to allow the Boy Scouts to proceed with the following projects at the Community Park:

Project 1: Build handrails onto existing bridge at park and build a second bridge.

Project 2: To dig a trail from the bridge to the baseball fields-with the city graveling it.

Motion was made by Middleton, seconded by Brock to make the following donation to the Englewood Recreation Association Football League. All ayes:
