Motion was made by Davis, seconded by Middleton to donate \$1000.00 to baseball teams: \$750.00 to 3 teams-Englewood Youth Baseball and \$250.00 to 1 team-Englewood Astro Baseball. All ayes.

Motion was made by Middleton, seconded by Davis to pass on first reading-Water and Sewer Leaks Ordinance. All ayes.

Motion was made by Middleton, seconded by Davis to pass on first reading-Garbage Pick-Up Ordinance. All ayes.

Motion was made by Davis, seconded by Middleton to send out clean up letter. All ayes.

Motion was made by Davis, seconded by Raper t grant Johnny Middleton use one review for his property located behind Romie Reid. All ayes.

Billie Koppa was present to ask the Board if the City had \$200,000.00 in funds. Mildred Rogers also wanted to discuss the route of Hwy 411 taking her home when it came through Englewood.
