

Minutes from the Commission Meeting held on

April 13, 1998

The Mayor and Board of Commissioners of the Town of Englewood met in regular session, Monday April 13, 1998, at 6:00 P.M. in the Assembly Room at Englewood City Hall.

The Meeting was called to order by Mayor Edward Simpson with Commissioners Davis, Raper, Brock and Middleton present.

Invocation was given by Commissioner Davis.

Mayor Simpson informed the Board that someone had destroyed the scarecrows in the children's garden and that the city was going to offer a reward for the apprehension of the party responsible.

Motion was made by Davis, seconded by Middleton to accept the March Minutes, All Ayes

Motion was made by Davis, seconded by Brock to Donate \$250.00 per team to the Englewood Baseball League. There were a total of 8 teams. All Ayes.

Motion was made by Middleton, seconded by Davis to accept the Monthly Billing Errors for March in the amount of -887.41. All Ayes.

Motion was made by Davis to hire Barbara Derrick as Pool Manager, Teresa Mason as assistant Pool Manager, 4 full-time Lifeguards, and 3 alternate lifeguards. All of these had already turned in their applications. Motion was seconded by Middleton. All Ayes.

Motion was made by Davis, seconded by Raper to set the opening day for the pool as Saturday, May Th. This will also be a free admission day. All Ayes.

Mayor Simpson stated that Clean-Up/ Fix-up week would be April Th-Th.

Motion was made by Middleton, seconded by Brock to buy a bush hog for the Mower, which would cost around \$800.00. All Ayes.

Motion was made by Brock, seconded by Middleton to hire Richard Robinson as a full time police officer and John Russel Wilburn as a reserve officer. All Ayes.

Motion was made by Middleton, seconded by Brock to hire Aaron Slack as the new Maintenance Worker (Full Time) and Gordon Ellis to work at the Water Plant part time. All Ayes.

Mayor Simpson gave special recognition to J.L. Gay for his years of service to the City and announced that Mr. Gay had decided to retire and presented him with a plaque.

Richard Moses was present and asked why he had not been given gas service to his house. Mr. Moses was told by Joe Cline that he would be given an estimate on this by the next Board Meeting.

Vilma Hickman was present with her mother to talk to the Board about the closure of the road behind their residents, Commissioner Middleton informed Mrs. Hickman that the property that joined hers on the back side was not owned by the City, but by the Church. Mrs. Hickman also stated that the County had told her that the road that was closed off was a City Street, Mayor Simpson said he would check into that.

Motion was made by Middleton, seconded by Raper to Adjourn the meeting. All Ayes.
