

Minutes from the Commission Meeting held on

June 11, 2001

The Mayor and Board of Commissioners of the Town of Englewood met in regular session on Monday, June 11, 2001 at 6:00 P.M., in the Assembly Room at Englewood City Hall.

Vice Mayor Lance McConkey called the meeting to order with the following present: Raymond Roach, Bob Cass and Edward Simpson. Ronnie Moses was not present.

McConkey informed those present that the cookout that was held at the Englewood Pool on July 2nd was a success.

Motion was made by Cass, seconded by Roach to accept the May 2001 minutes. All Ayes.

Motion was made by Simpson, seconded by Roach to accept on Third Reading Ordinance #040901.31- an ordinance to amend the zoning ordinance for the city of Englewood. All Ayes.

Jany Young was present stating that she had been told by Mayor Moses that there would be no charge for the Water and Sewer Raps for 121 Conner Drive. Mayor Moses was not present and the Board informed Ms. Young that the matter would be checked into and she would be contacted. Motion was made by Simpson, seconded by Cass to table Ms. Young's request. All Ayes.

James Thomas owner of Red Roof Carwash was present asking for a sewer adjustment as he did not have sewer at the car wash. The Board informed him that the Recorder would need to research this with Etowah and Athens to see if they offered any special rates to car washes. Motion was made by Simpson, seconded by Cass to have the Recorder research this matter. All Ayes.

The Board then reviewed bids for paving from the Rogers Group \$34996.00 and SEF/Weese Construction \$33739.00. Motion was made by Cass, seconded by Roach to accept the bid from SEF/Weese Construction and to add the road leading off the back of Conner Addition. All Ayes.

Motion was made by Roach, seconded by McConkey to accept on 1st Reading Ordinance #061101/32-zoning of Green Acres. Roach Aye, Cass Pass, Simpson Pass, McConkey Aye. Motion fails.

Motion was made by Cass, seconded by Simpson to donate \$250.00 to the Englewood Lions Club Horseshow. All Ayes.

Motion was made by Simpson, seconded by Roach to accept on 1st Reading the Budget for fiscal year 2001-2002. Roach Aye, Cass Pass, Simpson Aye, McConkey Aye.

After reviewing a letter from the Charlie Holden family, motion was made by Simpson, seconded by Roach to change the name of Juniper Street to Charlie Holden Street. All Ayes.

Motion was made by Roach, seconded by Cass to spend up to \$100.00 at the pool to purchase reserve tubes, floats and chairs and to paint the restroom floors. All Ayes.

Motion was made by Cass, seconded by Simpson to adjourn the meeting. All Ayes.
